

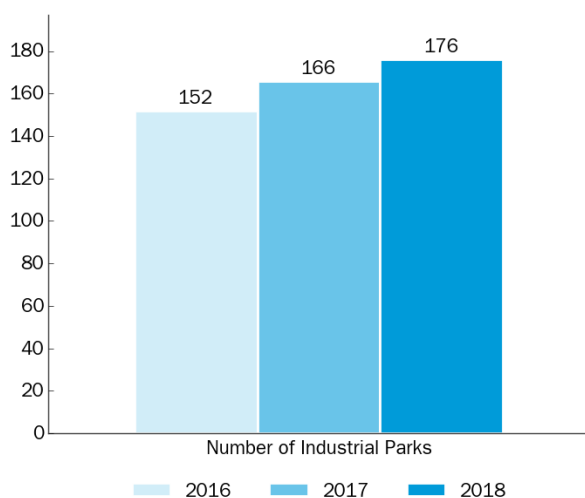
Statistical information summary of Geographical Information System for industrial parks



1. GENERAL INFORMATION

There are **176** operating and designed industrial parks in the Russian Federation.

Dynamics of the number of industrial parks, units

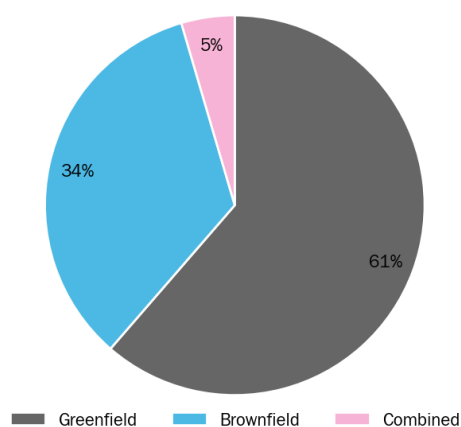

Among the operating and designed parks 41% are state projects, 58% are private projects and 1% have mixed ownership.

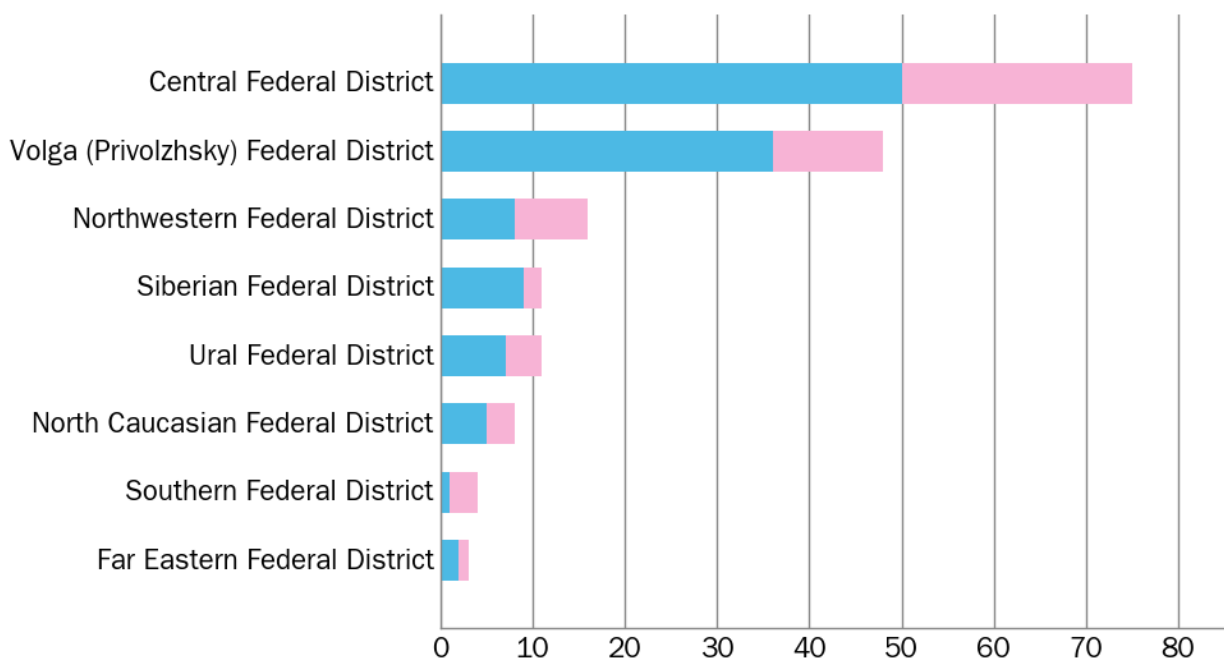

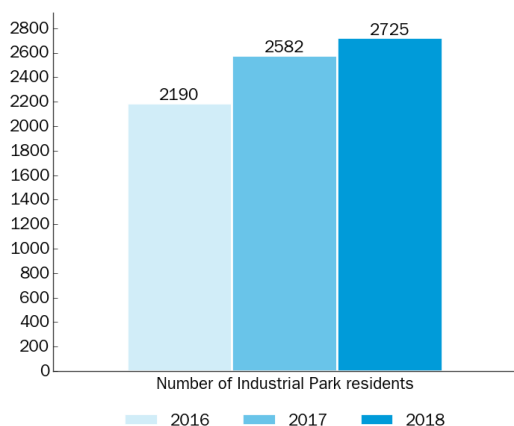

In 2018 the number of residents who commenced production in industrial parks, amounted to *1 527* units (115**).

Total number of created jobs in operating and designed industrial parks amounted to *160.90* thousand units (129**).

Total investments contributed by residents in operating and designed industrial parks cumulatively (2015-2017) as of 1st January, 2018 amounted to *1 158 442.97* million rubles. (67**). Including in 2017 *307 611.58* million rubles (23**).

Total volume of products manufactured by residents of operating and designed park in 2017 amounted to *451 674.76* million rubles (20), and the amount of tax revenue - *33 342.80* million rubles (24**).**

Contribution of park residents to the manufacturing industry of the Russian Federation in 2017 amounted to *1.14%* (16**) (average value for the subjects of the Russian Federation having operating and designed parks, amounted to *7.50%* (9*)).

Total number of operating and designed parks - participants of support programs in 2018 amounted to *90* units.
