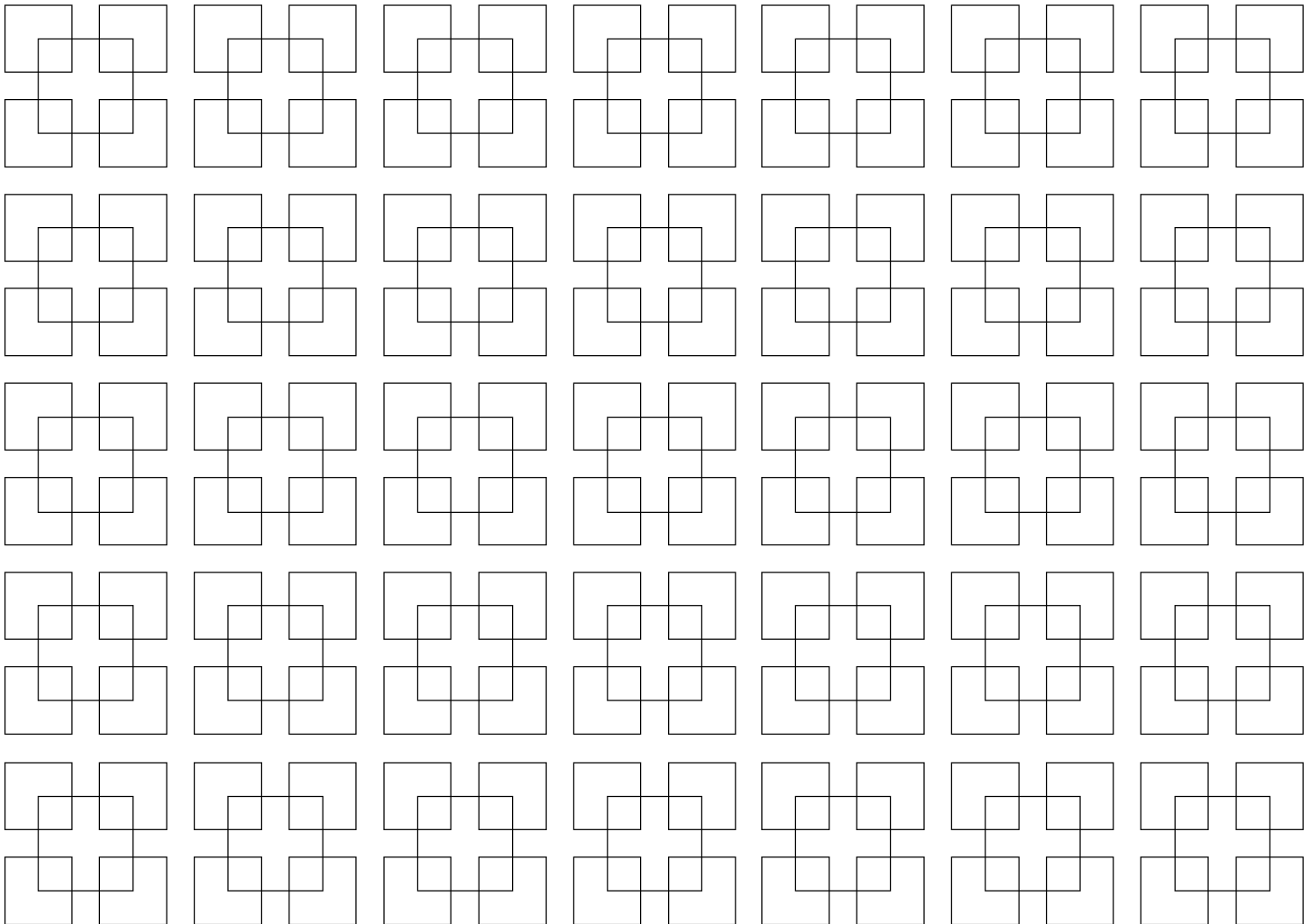


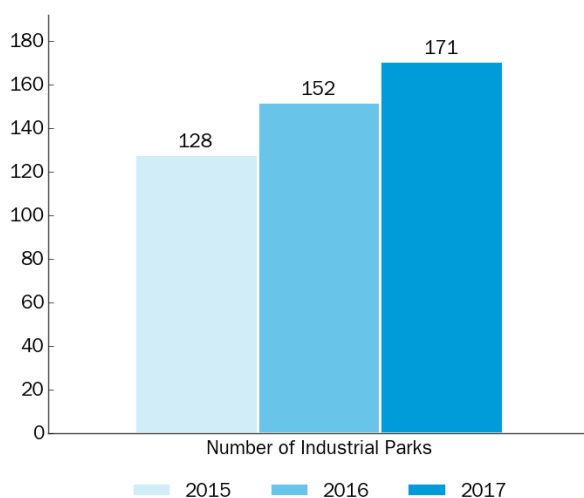
# Statistical information summary of Geographical Information System for industrial parks



## 1. GENERAL INFORMATION

There are **171** operating and designed industrial parks in the Russian Federation.

### Dynamics of the number of industrial parks, units

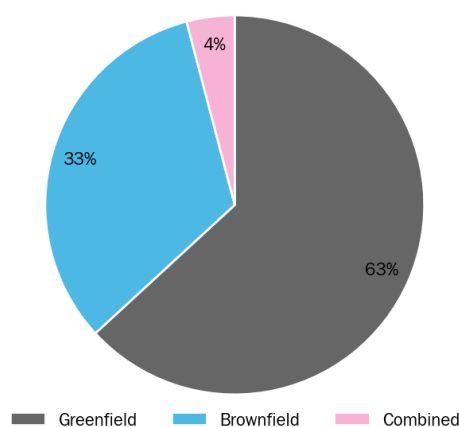

**Among the operating and designed parks 43% are state projects, 57% are private projects and 0% have mixed ownership.**

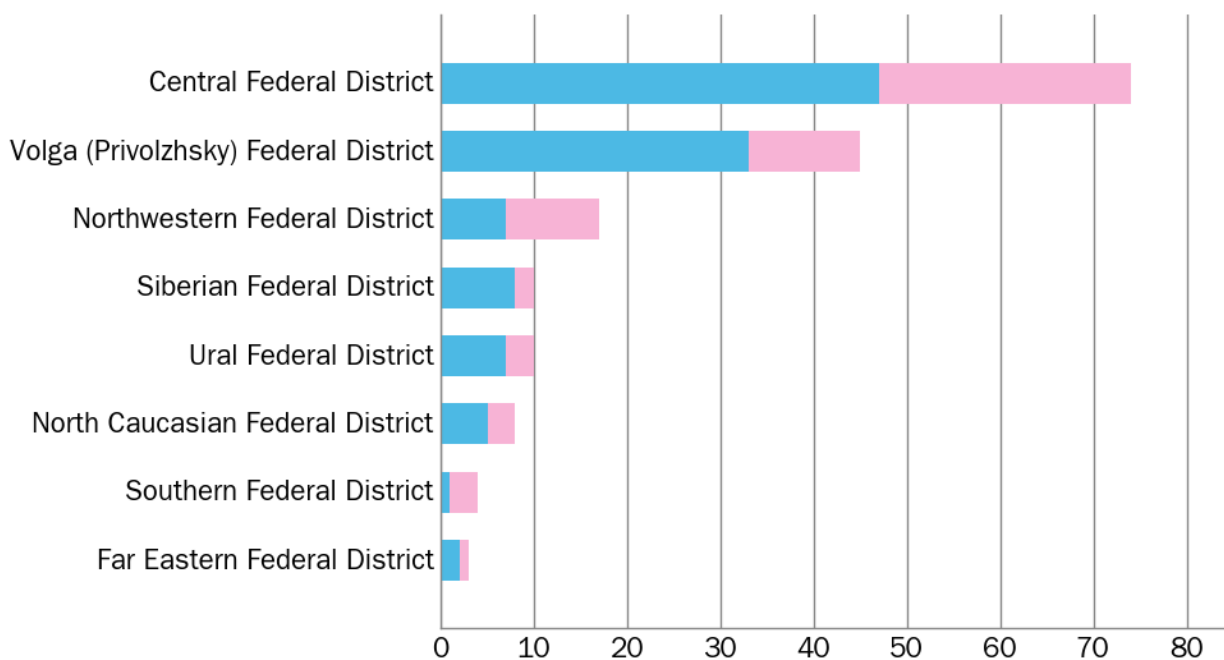

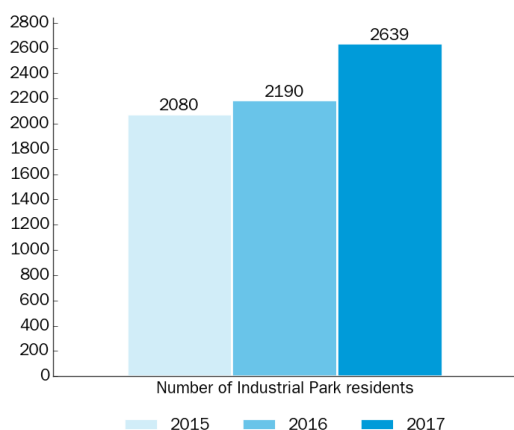

## 3. FINANCIAL AND ECONOMIC INDICATORS

**Residents registered in the operating and designed parks in 2017 - 2 639 (153\*\*).**

In 2017 the number of residents who commenced production in industrial parks, amounted to *1 437* units (111\*\*).

Total number of created jobs in operating and designed industrial parks amounted to *154.36* thousand units (125\*\*).

Total investments contributed by residents in operating and designed industrial parks cumulatively (2014-2016) as of 1st January, 2017 amounted to *1 148 040.87* million rubles. (84\*\*). Including in 2016 *391 381.36* million rubles (32\*\*).

**Total volume of products manufactured by residents of operating and designed park in 2016 amounted to 449 901.57 million rubles (28\*\*), and the amount of tax revenue - 43 553.79 million rubles (27\*\*).**

Contribution of park residents to the manufacturing industry of the Russian Federation in 2016 amounted to *1.25%* (18\*\*) (average value for the subjects of the Russian Federation having operating and designed parks, amounted to *8.33%* (12\*)).

**Total number of operating and designed parks - participants of support programs in 2017 amounted to 89 units.**
